LETTER FROM OUR PRESIDENT AND CEO

IN 2019 CDD prioritized expanding the knowledge and skills of the agency workforce. Thanks to additional funding from the state funneled through the Department of Mental Health (DMH), CDD was able to increase direct support staff wages, provide additional training to new and current supervisors, and engage individuals in new community activities. The resulting product? Quality care for persons with developmental disabilities, higher job satisfaction for staff, and continued service to the Kansas City metro area.

With the 2019 increase in DMH funding CDD was able to increase the starting salary of direct support professionals by just over 11%, and our home supervisors by 18%. With this increase in wages CDD has been able to attract hard-working, caring staff who are committed to serving the individuals supported by the agency.

CDD has high goals laid out for staff training. As many of you know, we purchased a small college several years ago with the vision of providing more college-like courses for our staff to expand their knowledge and increase their skill set. We hired two new staff for our training department so please look out for new training initiatives to be announced via our social media and newsletters.

Acknowledging the importance of community engagement and participation in social activities for individuals, CDD held the agency's first ever All-Star Awards Dinner and Dance Party in October of 2019. Emceed by local disabilities advocate, Rob Hughes, the dinner was attended by over 300 individuals, staff, members of the Board of Directors, and donors. Kansas City band The Local provided live

music for dancing. Kansas City Mayor Quinton Lucas proclaimed the date to be Center for Developmentally Disabled Day. In January, CDD held the ribbon-cutting ceremony for PALS University (People Actively Living Socially). This new day program will provide up to 60 individuals the opportunity to engage in seminars, employment skill building activities, and social programs, all aimed at enhancing an individual's day-to-day quality of life.

While speaking to the success of our fiscal year 2019-2020, we must also acknowledge the difficulties that ushered in the New Year. The global COVID-19 pandemic has forced many agencies, CDD included, to re-think the processes and priorities (and PPE!), required to keep individuals and staff safe and healthy. This has not been easy for anyone. We are grateful for the understanding of families and parents who have not been able to visit their loved one as they had prior to the pandemic.

Another difficult issue we have had to face in 2020 is the racial injustice that has plagued our country for far too long. Conversations around racial injustice and the need for diversity and inclusion at all levels, must be at the forefront of planning and strategy. CDD is determined to meet each challenge with purpose and grace.

Let's all hope for a less difficult 2021 and that we can get through the rest of 2020 by focusing on our health and the health of others.

Residential

CDD provides supports and services to individuals who need as little as a few hours a week of support to 24-hour supports. Our Direct Support Professionals provide a broad range of assistance to individuals based on their needs. Supports include personal care, meal preparation, transportation, medication administration and life skills development.



PALS University and Community Integration

Based out of our newly renovated enrichment center, CDD's new day program focuses on helping individuals develop and enhance independent living skills using curriculum designed to support their choice of daily activities and access to the greater community. Community integration activities are intended for individuals who want a structured day. Activities include volunteering, arts and crafts, movies, swimming, and many other activities that people are interested in doing. These services focus on skill development and support individuals with being a part of their community.



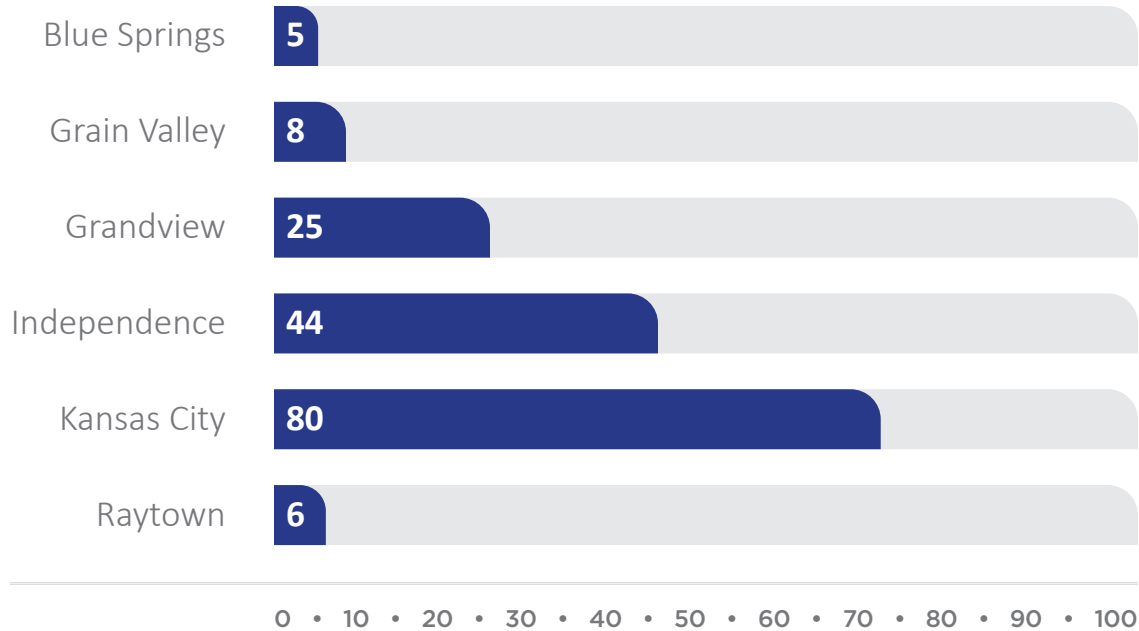
Respite:

CDD offers respite to individuals needing temporary care. Respite provides all supports offered in CDD's Residential Service homes and is available for up to 60 days per year for an individual.

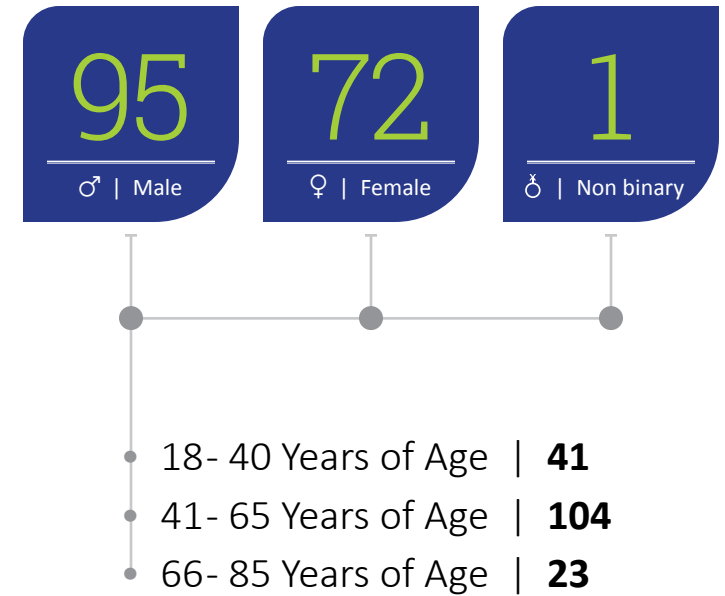


PEOPLE LIVING IN A COMMUNITY NEAR YOU

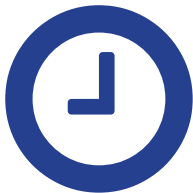
